Poster Abstract Submission Form

The New Horizons in Responsible Gambling Conference will take place in Vancouver, February 2–4, 2015. Researchers and industry professionals interested in presenting a poster at this year's conference must submit a 200–300 word abstract including an introduction to the topic (why it is important/what problem exists), the aims or objectives of the research, details of the methodology, findings (even if these are preliminary) and implications for the field.

Proposals should be submitted electronically via this submission form. The abstract can address research on any area of gambling, problem gambling or ways to provide a healthier approach to gambling. Each poster should make at least one recommendation or discussion on the practical relevance of the material.

Abstracts should be emailed to Matt Wilson (horizonsposter@bclc.com). Submissions must be received by **October 31, 2014**. Submitters will be notified by November 14, 2014 if their proposed poster has been accepted.

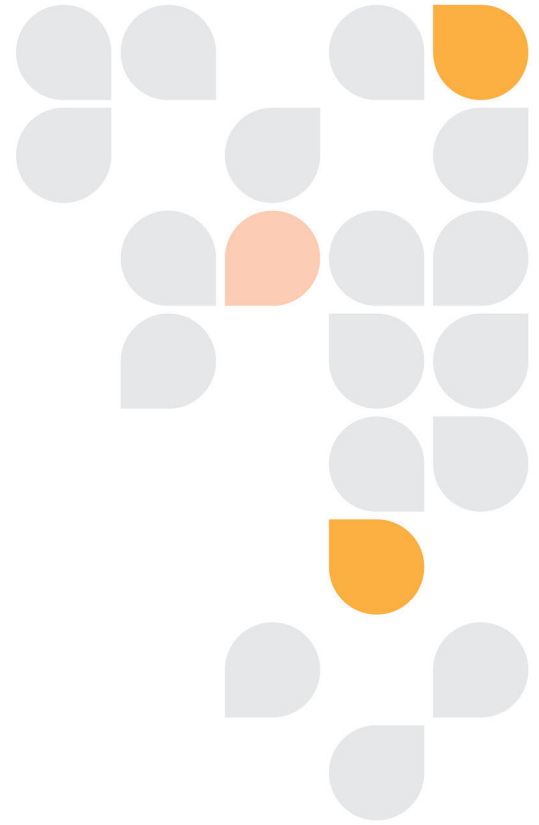

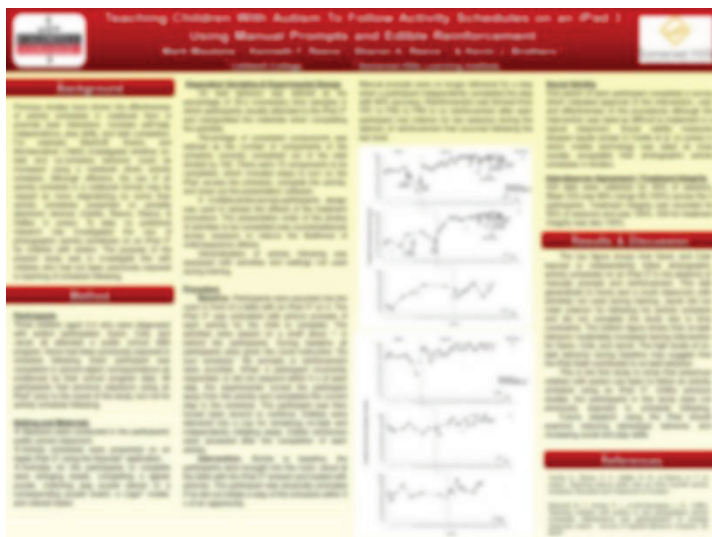

Poster Specifications

Presenters are encouraged to create a poster that uses a balance of text and figures which are sufficiently large to be read from a one metre distance. All figures and data should be well labeled and the poster should be able to stand on its own without explanation. Presenters are free to select their own template for their poster; however **posters that contain too much text will not be accepted**. Presenters are encouraged to use figures, illustrations, and other visuals to convey their information. Remember, conference delegates should be able to get a basic understanding of your research project without having to read paragraphs of text.

BCLC will print and mount posters on a foam background at no cost to participants. Poster dimensions cannot exceed 30" x 38". Participants should email posters as PDF files to size. Alternatively, presenters are also welcome to bring their own posters to be set-up during the Conference.

In addition to the poster that will be displayed during the conference, presenters must develop and submit a one-page summary that will be distributed to conference participants. BCLC will print copies for distribution at the Conference. Poster and summary files must be sent to Matt Wilson (horizonsposter@bclc.com) by **January 16, 2015**.

Poster Contest Rules & Regulations

ELIGIBILITY

1. The Poster Session is open to all delegates; however, to be eligible to win prizes associated with the poster contest, participants must:
 - a. attend the 2015 New Horizons Conference and present their poster to conference delegates and the poster judging committee.
 - b. develop a one-page summary of the poster content that will be distributed to conference delegates and the poster judging committee.
 - c. be enrolled in a post-secondary institution as a full-time or part-time student.

CONTEST DEADLINES

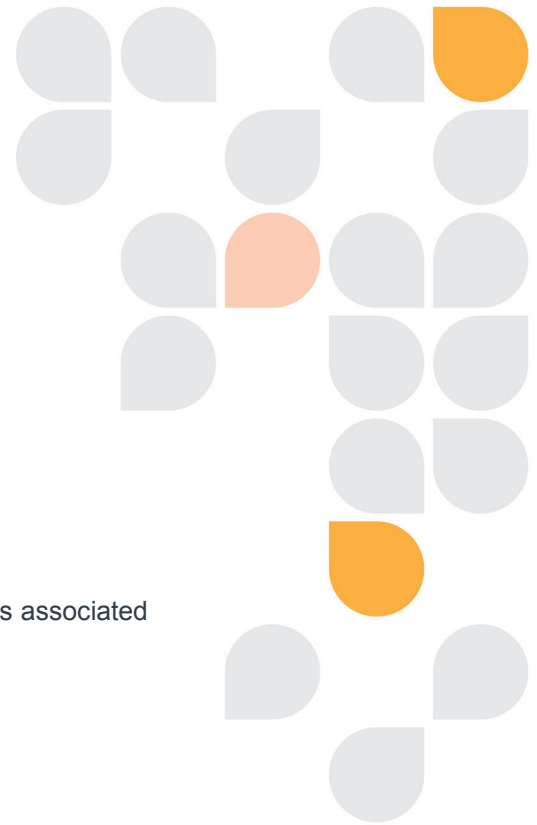
2. The deadline for submitting a poster abstract is **October 31, 2014**.
3. Notification of acceptance will be sent to participants by **November 14, 2014**.
4. Participants must submit their poster and one-page summary for printing by **January 16, 2015**.

PRIZES

5. The poster judging committee will select one grand prize winner from the eligible participants. The winner will receive a \$1000 cash prize.
6. Up to two additional cash prizes of up to \$500 may be awarded at the poster judging committee's discretion.
7. Only one participant per poster is eligible to receive a prize.

FURTHER CONDITIONS

8. The poster judging committee and/or the New Horizons in Responsible Gambling Conference Organizing Committee reserves the right, in its sole discretion, to alter, amend, suspend, or cancel the promotion, the prize or these conditions at any time without notice.
9. The poster judging committee reserves the right to disqualify participants that do not comply with these contest conditions.
10. All prizes are non-transferable.
11. All prizes must be accepted as awarded.
12. The poster judging committee decisions are final.
