



# Poster competition conditions

## QUALIFIED ENTRANT AND ENTRY

1. A Qualified Entrant must be:
  - a. a resident of Canada (excluding Québec);
  - b. the age of majority or older in his or her province or territory of residence; and
  - c. enrolled as a part-time or full-time student at a post-secondary institution.
2. Qualified Entrants do not include:
  - a. BCLC employees;
  - a. competition judges;
  - b. family and household members residing at the same address of any of the above (a-b); and
  - c. BCLC gaming facility barred individuals.
3. To obtain a Qualified Entry, you must be a Qualified Entrant and:
  - a. accurately complete a poster abstract application in the required BCLC form (Application) available online at [www.horizonsrg.com](http://www.horizonsrg.com);
  - b. email the Application to [horizonsrg@bclc.com](mailto:horizonsrg@bclc.com) by December 14, 2018 at 11:59 pm;
  - c. receive BCLC's acceptance to present your poster at the New Horizons Conference taking place in Vancouver, British Columbia March 12–14, 2019 (Conference);

- d. submit a one-page poster summary to [horizonsrg@bclc.com](mailto:horizonsrg@bclc.com) by February 13, 2019 at 11:59 pm;
- e. present your submitted poster to a panel of three judges (Panel) at your assigned time on March 14, 2019; the presentation must be made in person at the Conference.

No purchase required. Maximum one entry per person.  
Poster Competition valid until March 14, 2019.

## WINNER SELECTION

4. Qualified Entries will be judged and ranked by the Panel based on its opinion of the quality of the poster, poster summary and in-person presentation.
5. BCLC will announce the first-ranked Qualified Entry (Selected Entry) at the Conference on March 14, 2019.

In addition, the entrant of the Selected Entry (Selected Entrant) may be notified by telephone or e-mail. If BCLC does not receive a response from the Selected Entrant within seven (7) days, BCLC may disqualify the Selected Entry and contact the next-ranked Selected Entrant (by judged ranking).
6. In order for a Selected Entrant to receive a prize for a Selected Entry and be designated the "Winner", the Selected Entrant must provide proof of eligibility as may be reasonably requested by BCLC.

## PRIZES

7. One prize, consisting of \$1,000 CDN paid by cheque, is available to be won in this competition.
8. In the event of a group entry, all group members must be Qualified Entrants and only one prize will be awarded. The prize will be delivered to the presenting author identified on the Application.
9. BCLC reserves the right to substitute the awarded prize with a prize of approximately equal or greater value. The prize must be accepted as awarded and is non-transferable.

10. Odds of winning are dependent upon the number of Qualified Entries received in accordance with these Competition Conditions.
11. BCLC reserves the right to disqualify entrants and/or entries that do not comply with these competition conditions.
12. BCLC is not responsible for any entry, or transmission of the entry that is incorrect, omitted, illegible, late, lost, delayed, garbled, destroyed, misdirected or not recorded due to failure(s) or error(s) for any reason of the entrant, internet, internet provider(s) or any computer(s).
